Passover is a Jewish holiday commemorating the Israelites' escape, or Exodus, from slavery in ancient Egypt. It is a seven- to eight-day celebration to honor Jewish sovereignty, featuring traditions such as the sharing of a special meal (Seder), the removal of leavened foods (chametz), and the use of matzah (unleavened bread).

Easter is the most important festival in the Christian calendar, celebrating the belief in Jesus Christ's resurrection three days after his crucifixion. 
